

Safety Vinyl Floor Program

GENERAL CLEANING PROCEDURE

DOMESTIC MAINTENANCE PROCEDURE:

Frequency of maintenance will depend on the installation type and degree of traffic. This floor type is mainly used in wet areas such as bathrooms and laundries.

STEP 1 Remove all loose dirt and foreign matter by sweeping. The use of a soft broom is most effective.

STEP 2 Damp clean with a cotton or sponge squeeze mop and **PEERLESS VERSADET FLOOR CLEANER** diluted 1 part to 80 parts water (1/2 cup to bucket of water). Rinse with clean water.

STEP 3 Dirtier areas should be wet cleaned by scrubbing with a deck scrubber and **PEERLESS VERSADET** diluted 1 part to 40 parts warm water (1 cup to bucket of water). Allow adequate soak time. Use a squeeze mop to pick up the dirty residue. Rinse with clean water.

The provision of entrance matting will help prevent the entry of damaging and unsightly dirt and grit.

COMMERCIAL MAINTENANCE PROCEDURE:

Frequency of maintenance will depend on the installation type and degree of traffic. This floor type is mainly used in wet areas such as kitchens, bathrooms and laundries.

STEP 1 Remove all loose dirt and foreign matter by sweeping or vacuuming. The use of a soft broom is most effective.

STEP 2 Wet clean by mopping and scrubbing with a deck scrubber and **PEERLESS VERSADET FLOOR CLEANER** diluted 1 part to 40 parts warm water (1 cup to bucket of water). Allow adequate soak time. Use a moss rubber squeegee to flush the dirty residue to floor waste or pick up with mop and bucket. Rinse with clean water.

Mechanical cleaning equipment such as an Auto Scrubber Dryer should be used in larger areas with **PEERLESS VERSADET** diluted 1 part to 40 parts water (1 cup to bucket of water).

For heavily soiled areas, every 4th service (or as required) **PEERLESS ACTIV SRA HEAVY DUTY CLEANER** can be used at a 40:1 dilution rate instead of **PEERLESS VERSADET**. Alkaline detergents (Activ SRA) should not be used as the main cleaner as they allow deposits of insoluble salts to build up and affect the plasticisers in the vinyl.

In areas requiring sanitizing, eg. Bathrooms in nursing homes, **PEERLESS FUTURE DISINFECTANT** should be substituted for **VERSADET** in the above schedule.

The provision of entrance matting will help prevent the entry of damaging and unsightly dirt and grit.
