1 PRODUCT DESCRIPTION

2 AREAS OF APPLICATION

Primer for wood and parquet floors before top coating with all strato lacquers.

3 APPLICATION

Apply rich and evenly with the Aquatop-Roller.

- The professionally sanded and grouted subsurface must be in a clean, dry condition, free of oil, wax and dust.
- Room and material temperature must not be allowed to fall below +15°C during application and drying time
- The rules of the professional trade are to be observed.

4 CONSUMPTION

Approx. 8-10 m²/l (100-120 ml/m²). In the case of highly absorbing wood increased consumption is possible.

5 DRYING TIME

Can be carefully walked on, or worked on again with UA- and PU-lacquers, after about 60-90 minutes (at 20 °C and 50% relative humidity, ventilation).

Low temperatures, increased humidity, poor ventilation and drying inhibiting wood ingredients can extend the drying time substantially.

7 STORAGE

Store in a cool dry place. Can be stored for 24 months from date of manufacture in unopened original canister. Keep coating materials out of the reach of children.
